RULES AND REGULATIONS OF DIRECT SELLER

1. **Wellness Samridhi Pvt. Ltd.** is incorporated under the Indian Companies Act, 1956 and registered with the Registrar of Companies, Palwal, Haryana.
2. The applicant may be an Individual, Partnership Firm, Private Company, or Proprietorship. Upon successful completion of registration, he/she/it will be called a **Direct Seller (DS)**.
3. During registration, an Individual must submit a copy of the relevant Identification Proof. A Partnership Firm / Private Company / Proprietorship must submit a Partnership Deed or Company Registration Certificate, as applicable.
4. A Partnership Firm / Private Company / Proprietorship must submit a Power of Attorney authorizing one person to deal and correspond with the company. Such person must be a **DS**.
5. An Individual applicant must be a major and have the legal capacity to enter into a contract independently to conduct the business of **Wellness Samridhi**.
6. All **Direct Sellers** must adhere to the Company's code of conduct and business ethics.
7. A **Direct Seller** has the right to buy, sell, and promote **Wellness Samridhi** products globally.
8. The **DS** has the right to purchase products at the Distributor Price (DP) and must sell them at the Company's Maximum Retail Price (MRP) only. The products must not be sold below or above the MRP.
9. The **DS** must sell the products only through Direct Selling Marketing.
10. The **Direct Seller** will enjoy a margin of 40-50% on the Distributor Price (DP).
11. All prices are inclusive of taxes. Taxes, duties, and levies will be applied as per the laws of the land.
12. The **Direct Seller** shall abide by the sales policies and procedures of the Company, as amended from time to time. The Company shall not be responsible in any manner whatsoever to the **DS** or any third party for disputes, claims, or losses arising from the **DS's** non-compliance with the Company's sales policy.
13. The **Direct Seller** will receive bonuses or incentives based on his/her individual or team business performance, as per the Company's Business Plan.
14. Bonuses will be paid weekly after deducting applicable taxes and TDS as per the Indian Income Tax Act. PAN Number is mandatory for receiving bonuses.
15. An individual must not apply for another **DS** ID. If such duplication occurs, the second ID will be automatically terminated without transferring any business to the first ID.
16. Husband and Wife are considered as the same person, therefore both must work in the same team only. If they work in different teams, the second ID will be terminated.
17. A **Direct Seller** must not represent himself/herself as an employee of **Wellness Samridhi** and must not use the company's stationery, logo, or trademark relating to the Company's identity. There is no agency or employment relationship with the Company.
18. The Company shall not be responsible for any relationship between the **DS** and the Stockiest, or for any past, present, or future liabilities incurred by them while selling **Wellness Samridhi** products.
19. The **DS** must promote **Wellness Samridhi** products only according to the guidance and information provided in the Company's printed materials and shall not make any revisions or amendments to such information.
20. Cross sponsoring of **Direct Sellers** is strictly prohibited. If found, the second **DS** ID business will be terminated without prior notice.
21. An individual who pays the registration fee online must submit ID proof and PAN copy along with the registration printout directly to the Stockiest Office.
22. The Company reserves the right to terminate a **DS** who fails to comply with the rules and regulations or acts against the business ethics, without prior notice.
23. Any **Direct Seller (DS)** found to be simultaneously engaged in another direct selling business will be terminated from **Wellness Samridhi** without prior notice.
24. The Company does not entertain direct sales. All sales transactions must be routed only through authorized Stockiest.
25. By signing or authorizing the application form, the **Direct Seller** expressly agrees to abide by and be bound by the Company's rules and regulations.
26. All disputes or differences arising from these terms shall be subject to the jurisdiction of the courts in Palwal, Haryana only.
27. **Wellness Samridhi** reserves the right to change or amend policies, rules, regulations, and the business plan from time to time governing the conduct of distributors, and its decision shall be final and binding on the distributor.
